Databricks Terms of Use - Google Models

In this page, learn about terms applicable to you and your Authorized Users' use of the Google Models (proprietary models developed by Google and made available as a first party offering on Databricks). You are responsible for complying with these terms when using Google Models offered through Databricks.

Customer and Customer's Authorized Users may not, and may not allow any third party to:

- Access or use Google Models for activities where the use or failure of the models would reasonably be expected to lead to death, personal injury, or environmental or property damage (such as the creation or operation of nuclear facilities, air traffic control, life support systems, or weaponry);
- 2. Engage in cryptocurrency mining in connection with the Google Models;
- 3. Operate or enable any telecommunications service or in connection with any that allows Authorized Users to place calls or to receive calls from any public switched telephone network in connection with the Google Models;
- 4. Use Google Models in connection with materials or activities that are subject to the International Traffic in Arms Regulations (ITAR) maintained by the United States Department of State;

Benchmarking. Customer and Customer's Authorized Users may conduct benchmark tests of the Google Models. Customers and Customer's Authorized Users may not publicly disclose the results of such benchmark tests. Notwithstanding the foregoing, Customer and Customer's Authorized Users may not conduct benchmark tests of Google Models on behalf of a hyperscale public cloud provider.
